For Domestic shipments at Group 1 and Group 2 Facilities, the event used to determine the Day-of-Notification will be the Planned Out-gate (POG) date and time (where applicable) when it occurs after the notification (Patron Notification). However, if the POG is more than 3 days after Patron Notification, then the Day-of-Notification will be limited to Patron Notification plus 3 days. Otherwise, the event used to determine the Day-of-Notification will be either Patron Notification (PN) or Estimated Time of Notification (ETN), whichever occurs at the later date and time. When Patron Notification (PN) occurs after both POG and ETN, the Day-of-Notification will be Patron Notification plus 1 day.

For International shipments that terminate at all Group 1 and Group 2 Facilities, the event used to determine the Day-of-Notification will be Patron Notification (PN).

For shipments terminating at all Group 1 and Group 2 locations, free time will begin at 12:01 following the Day-of-Notification regardless of when notification occurs.

The table below shows the event sequence (left to right) that determines the day of notification, and if an additional 24 hours Free Time will be applied for Domestic shipments.
